JOINING OLDINA SKI CLUB

2023

History: The club was founded in 1960 and it is in a sound financial situation and has no debt. The club has a cap of 120 members and a membership waiting list will be established when the cap is reached. The club currently seeking new members as some members retire from skiing.

Lodge details and access: The new lodge was built in 1982 to comply with revised building regulations and to reflect increased expectations of members in terms of quality of accommodation. The club has a 20-year lease with NSW Parks & Wildlife until 2028 with an option to extend for 3 x 10 more years. The lodge is located at South Perisher about a 10-minute walk from the Ski Tube Terminal. It has extensive views looking north from Mt. Perisher to the front valley. Hans Oversnow operates transport to take guests to the lodge with luggage and leaves from the Ski Tube Terminal. It is possible to ski to the front valley from the front door of Oldina Ski Club (season permitting). A small ski cart is left at the bridge (near the Quad chair) to bring your skis home each afternoon. The club comprises ground floor with Ski lockers, drying room, and ski storage. There is a separate toilet and shower facility for those who wish to ski on their checkout day and freshen up before travelling home. The first floor has the kitchen, common lounge/dining area and 4 bedrooms each with en-suites. The second floor has 5 bedrooms all with en-suites and a games area. The club is licensed for 15 guests and employs a full-time manager in the winter season, leaving 14 beds for guests.

Accommodation rates: These include a cooked breakfast and a 3-course evening meal. Lunch is not included but on inclement days provision is made for sandwiches, soups, and snacks etc. The club prides itself both on the quality of its food and the time our managers stay with us. A recent manager was with us for 6 years and another for 11 years. This helps to engender the club lodge atmosphere. The club is open to members and their guests outside the winter season on a self-catering basis at very nominal rates. Club operations: The club has an active board of 7 directors who are dedicated to both improving and maintaining the building to a high standard and ensuring the Club is run on a sound financial basis.

The joining fee in 2022 is \$5,500 (the joining fee may rise annually):

This comprises an entry fee of \$5,500 (incl. GST) + 800 x \$1shares = **\$6,300**. The entry fee can be paid in **3 instalments** via EFT: **\$2,634 when application approved, \$1,833 in year 2 and \$1,833 in year 3**. Payment of the first instalment entitles you to members' rates. Based on the current rates in high season the saving members make compared to the non-member means a new member will recover their entry fee in 7 weeks of high season skiing. An **annual subscription fee** also applies which is intended to cover maintenance costs and for **2022 is \$260**. The club is registered as a cooperative which means that shares cannot be bought and sold on the open market. Current rules permit the shares can be passed onto any person and the entry fee to be waived.

Interested in joining:

If you are interested in applying for membership, please **complete the Membership Application Form** which is attached. To become a member you must:

1. have **stayed a minimum of 5 nights at the lodge** (state on the form: when you stayed, for how many nights and who was in the lodge at the time). Go to the web site for details on how to book into the lodge or email our booking officer at bookings@oldinaperisher.com.au. This gives you the opportunity to experience first-hand the ambience of a club lodge and to meet some existing members. By socialising with existing members their expectations will be noticeably clear. These might be summarised by three simple criteria: to have fun, to enjoy skiing and to respect the views of other members.
2. **gain the support of two (2) current members** and have them complete their section of the application form.
3. be **interviewed by at least one board director** (they are also to sign the application form) – call the Club Secretary to arrange a quick meeting with a director (interview will be either in person or via Skype).
4. **Please then send your completed application form to the Club Secretary** and your application will be reviewed and voted on by the Board of Directors. The Club Secretary will notify you within a few weeks of your membership outcome. When instructed, transfer funds **\$2,634**, via Direct Debit into Oldina Bank Account. New members are encouraged to attend the Oldina Annual General Meeting after their membership has been approved (early May).
